Using your Learner's Guide

OVERVIEW:

Humana has three electronic application methods that can be used instead of paper applications:

- **MAPA** – Medicare Advantage Paperless Application, which can be downloaded onto **laptop computers** and is useable with two signature methods: a digital signature pad or electronic signature process (an auto-generated email to the client). Doesn't require live internet connectivity; applications can be transmitted to Humana later in the day (from home or the office).
- **iMAPA** – Medicare Advantage Paperless Application, which can be downloaded onto **iPads** and is useable with two signature methods: digital signature on iPad or electronic signature process (an auto-generated email to the client). Doesn't require live internet connectivity; applications can be transmitted to Humana later in the day (from home or the office).
- **FastApp** – Accessible through Humana's agent portal and requires internet connectivity.

NAVIGATION:

- Each person learns in different ways, thus, this Learner's Guide will provide different "paths" for you to take. Each path will attempt to accommodate the needs of different learners. You may select 1 path, or take them all. In the end, do what you need to do in order to be confident and successful with each tool.
